There has been questions on why we have a Board of Directors with the majority of members not residents of Olympic Village. Olympic Village, Inc. (OVI) is a state of Wisconsin corporation that has been designated

as a 501(c)(3) federal tax exempt organization by the Internal Revenue Service (IRS). As such, the State of Wisconsin and municipal taxing entities such as the City of Sun Prairie recognize this IRS designation as qualifying for exemption from state and local taxation. The OVI Bylaws require that the makeup of the Board of Directors of OVI must contain a majority of non-residents. This was among the significant factors that the IRS considered in granting the non-profit status of OVI.
